I agree to acknowledge and comply with all of the CDWCO, CDW, and Owners' rules and regulations pertaining to any and all equine activities occurring at the Owners' facility and I agree to my personal responsibility for wearing protective gear appropriate for equine activities to ensure my or Rider's safety while engaging in such activities.
- 4. I understand the risks involved in equine activities and I AGREE TO ASSUME ANY AND ALL RISKS INVOLVED IN RIDER'S USE OF OR PRESENCE UPON OWNERS' property while engaging in any equine activity without limitation and including the risks of death, bodily injury, property damage, falls, kicks, bites, unavailability of emergency medical care, and/or the ordinary negligence and/or deliberate act of another person.
- 5. I agree that CDWCO, its officers, directors, members and volunteers; CDW, its officers, directors, members and volunteers; the Owners' and their agents and employees; and other participating riders (collectively the "Released Parties") are NOT liable for any injury to or the death of Rider, a participant in equine activities, or someone observing the activities resulting from the inherent risks of equine activities.
